

TOWN OF LOCUST FORK

ORDINANCE 54

PROVIDING FOR ANNEXATION OF REAL PROPERTY

WHEREAS, on the 9th day of May, 2023, the owner of the real property hereinafter described, did file with the Town Clerk a Petition requesting that the said tract of land be annexed to and become a part of the Town of Locust Fork, Alabama; and

WHEREAS, said Petition did contain the signature of the owner of the described territory and a map of the said property showing its relationship to the corporate limits of the Town of Locust Fork, Alabama; and

WHEREAS, the governing body did determine that it is in the public interest that said parcel of real property be annexed to the Town of Locust Fork, Alabama, and it did further determine that all legal requirements for annexing said real property have been met pursuant to § 11-42-20 through § 11-42-24 Code of Alabama (1975).

NOW THEREFORE, be it ordained by the Town Council of the Town of Locust Fork as follows:

SECTION 1. The Council of the Town of Locust Fork, Alabama, finds and declares as the legislative body of the Town that it is in the best interests of the citizens of the Town, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the Town of Locust Fork, Alabama.

SECTION 2. The boundary lines of the Town of Locust Fork, Alabama, be and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the Town of Locust Fork, Alabama, and in addition thereto the following described territory to-wit:

Lot 1 of Calverts Tucker Mt. Subdivision as recorded in Map Cabinet "A", Slide 128, page 10, in the Office of Judge of Probate, Blount County, Alabama.

SECTION 3. This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of

the petition of the property owner, shall be filed with the Probate Judge of Blount County, Alabama.


SECTION 4. The territory described in this ordinance shall become a part of the corporate limits of the Town of Locust Fork, Alabama, upon publication of this ordinance as set forth in Section 3, above.


