Regular Council Meeting

The Town Council of Locust Fork, Alabama met at 6:00 p.m. at town hall, with Mayor Joseph B. Hughes presiding and calling the meeting to order. Council Powell opened the meeting in prayer. Members present Council Members, Weslie Powell, Barbara Richey, Robert Chamblee, Joey White, Clerk April Wheeler and Attorney Jeff Sherrer.
